HOURS: 15 hour openings; NSRAA staff has the option to reduce to 13 hour openings during cost recovery weeks when Deep Inlet is closed if they feel not enough fish are getting through into the inlet for cost recovery needs.

Opening Times :

Seine - 5 a.m. - 8 p.m. through August 13

Seine - 6 a.m. - 9 p.m. beginning August 16

Gillnet - 5 a.m. - 8 p.m. through August 12

Gillnet - 6 a.m. - 9 p.m. beginning August 18

At some time in early September closing time will change from 9 p.m. to 8 p.m.

Troll - 12:01 a.m. - 11:59 pm on all dates shown above

Deep Inlet Fishing Schedule - 2009

A. Chinook Management (2:1 Seine:Gillnet) May 31 - June 20, 2009.

The Deep Inlet THA will open on May 31, 2009 for commercial fishing to access hatchery Chinook salmon.

Fishing dates are shown on the calendar above. Please check ADF&G News Releases for the official early season schedule.

****There will be no modification to the western boundary line of the THA during Chinook management weeks as proposed at the NSRAA board meeting. The current boundary is in regulation and cannot be changed without a Board of Fish action.**

****Gillnet Mesh restriction (minimum of 6 inch mesh) will be in place from May 31 through June 20.**

B. Chum Management (1:1 Seine:Gillnet) June 21 - end of season, 2009.

NSRAA's cost recovery goal for Medvejie / Deep Inlet is **130,000** chum (1.04 million pounds) for the 2009 season.

Cost recovery fishing will begin some time around July 1.

Waters in Deep Inlet south of a line bounded by the points (56° 58.50' N. latitude, 135° 16.50' W. longitude) and (56°58.35' N. latitude, 135° 17.10' W. longitude) will be closed to commercial fishing beginning 12:01 a.m. Sunday, June 28 to facilitate cost recovery efforts.

In-Season changes may occur; it is anticipated that the inside of Deep Inlet will be closed to commercial fishing during weeks marked CR in the calendar above.

Deep Inlet Fishing Schedule - 2009

******* Re-opening plan at the end of the cost recovery harvest *******

Normal Schedule - with fisheries open in the outer THA during cost recovery.
A 24-hour notice is required to re-open the inner portion of Deep Inlet.

When NSRAA's cost recovery harvest is complete on any day of the week except Friday or Saturday (and the Deep Inlet closure line has been in place):

A re-opening announcement (*ADF&G News Release) will be made on the day CR is complete.

The normal gear schedule will remain in effect in the **outer THA**.

The inlet will remain closed for the remainder of the week, with **Troll fishing open in the entire THA from 12:01 a.m. - 11:59 pm on the Saturday following the cost recovery completion date.**

In the event that cost recovery is completed on a Friday or Saturday:

A 24-hour notice is required to re-open the inlet. NSRAA staff will do their best to anticipate the day that CR will be completed and make the re-opening announcement (*ADF&G News Release) on Thursday.

This Thursday announcement will either allow Trollers to fish inside the inlet:

Full-day Saturday (12:01 a.m. - 11:59 p.m.) - if CR is expected to be completed on Friday.

Half-day Saturday (12:01 p.m. - 11:59 p.m.) - if CR is expected to be completed on Saturday morning.

No Troll Saturday - if CR is expected to be completed Saturday afternoon.

(Note that trolling is already allowed in the outer THA per the normal schedule.)

On the following day (Sunday) the normal schedule will resume, beginning with the entire THA open to seining on that Sunday.

**Suspended Schedule - with entire THA closed to commercial fishing during cost recovery.
A 24-hour notice is required to re-open the THA.**

When NSRAA's cost recovery harvest is complete on any day of the week except Friday or Saturday:

A re-opening announcement (*ADF&G News Release) will be made on the day CR is complete.

Commercial fishing will resume in the **outer THA on the second day following completion** with the **normal gear schedule**; but the inlet **will remain closed for the remainder of the week**, with Troll fishing open in the **entire THA from 12:01 a.m. - 11:59 pm on the Saturday following the cost recovery completion date.**

In the event that cost recovery is completed on a Friday or Saturday:

A 24-hour notice is required to re-open the THA. NSRAA staff will do their best to anticipate the day that CR will be completed and make the re-opening announcement (*ADF&G News Release) on Thursday.

This Thursday announcement will either allow Trollers to fish inside the entire THA:

Full-day Saturday (12:01 a.m. - 11:59 p.m.) - if CR is expected to be completed on Friday.

Half-day Saturday (12:01 p.m. - 11:59 p.m.) - if CR is expected to be completed on Saturday morning.

No Troll Saturday - if CR is expected to be completed Saturday afternoon.

On the following day (Sunday) the normal schedule will resume, beginning with the entire THA open to seining on that Sunday.

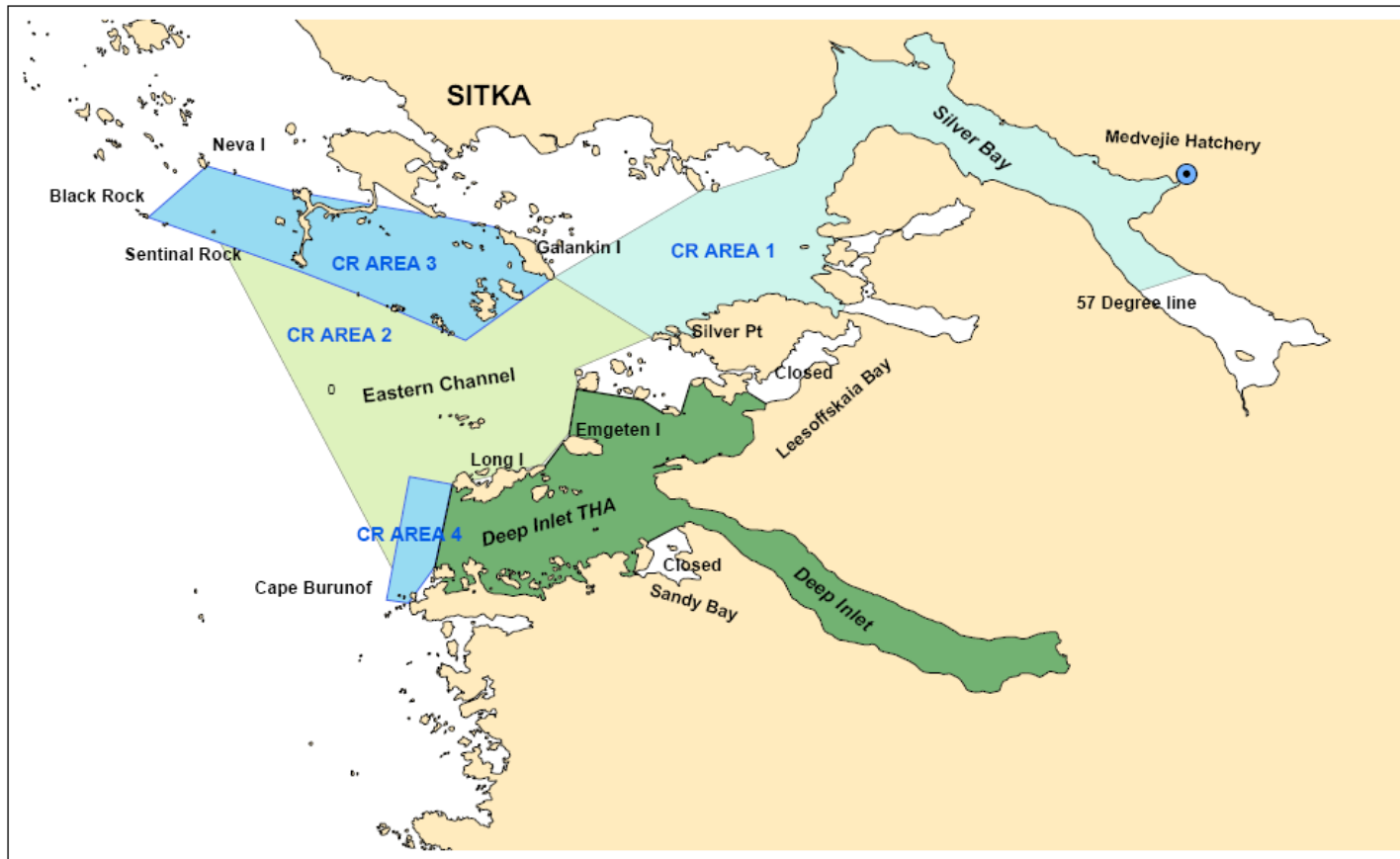

Deep Inlet Terminal Harvest Area & Cost Recovery Boundaries

Cost Recovery Area 1 = Open all season

Cost Recovery Area 2 = Open until 12:01 am July 22 and re-open 12:01 am the day before the end of Troll Closure, or August 20 if there is no closure

Cost Recovery Area 3 = New Area (2005) Open all season

Cost Recovery Area 4 = New Area (2005) Open all season when Deep Inlet THA is open for CR

Deep Inlet THA = Open for cost recovery on scheduled CR days
