DEEP INLET TERMINAL HARVEST AREA FISHERIES ANNOUNCEMENT

Sitka...The Alaska Department of Fish and Game announced today the following information in cooperation with the Northern Southeast Regional Aquaculture Association (NSRAA) concerning common property net and troll fisheries in the Deep Inlet Terminal Harvest Area (THA).

The Alaska Board of Fisheries, during its March 2015 meeting, passed regulations requiring the time ratio for gillnet openings to seine openings as 2:1 for the 2015–2017 seasons; except from the third Sunday in June through statistical week 30, the time ratio for gillnet openings to seine openings is 1:1. However, if the postseason preliminary enhanced salmon harvest value data from the previous season indicates the seine gear group is within its enhanced salmon allocation percentage range, based on the five-year rolling average as described in 5 AAC 33.364, the time ratio for gillnet openings to seine openings is 2:1 for the entire season. Preliminary 2016 enhanced salmon harvest value estimates, using a 5 year rolling average, shows the seine gear group behind in its allocation range. Therefore, from the third Sunday in June through statistical week 30, the time ratio for gillnet openings to seine openings is one to one.

The Deep Inlet THA is scheduled to open beginning May 28, 2017. This season, NSRAA is projecting a total return of 19,100 Chinook salmon, 52,000 coho salmon, and 1,355,000 chum salmon to the Medvejie Hatchery and Deep Inlet THA. This season, 90,000 chum salmon are needed for broodstock, and up to 360,000 chum salmon are needed for cost recovery, depending on price. NSRAA anticipates a closure of the THA in early August will be necessary to complete cost recovery needs.

The following rotation schedule will be in effect through September 30, 2017, unless changed by a subsequent announcement:

Seine:

- From May 28 through June 17, the purse seine fishery will be open from 5:00 a.m. to 8:00 p.m., Sunday and Wednesday of each week.
- From June 18 through July 29, the purse seine fishery will be open from 5:00 a.m. to 8:00 p.m., Sunday, Thursday, and Friday of each week.
- From July 30 through August 12, the purse seine fishery will be open from 5:00 a.m. to 8:00 p.m., Sunday and Wednesday of each week.
- From August 13 through September 30, the purse seine fishery will be open from 6:00 a.m. to 9:00 p.m., Sunday and Wednesday of each week.

Gillnet:

- From May 28 through June 17, the drift gillnet fishery will be open from 5:00 a.m. to 8:00 p.m., Monday, Tuesday, Thursday, and Friday of each week.
- From June 18 through July 29, the drift gillnet fishery will be open from 5:00 a.m. to 8:00 p.m., Monday, Tuesday, and Wednesday of each week.
- From July 30 through August 12, the drift gillnet fishery will be open from 5:00 a.m. to 8:00 p.m., Monday, Tuesday, Thursday, and Friday of each week.
- From August 13 through September 30, the drift gillnet fishery will be open from 6:00 a.m. to 9:00 p.m., Monday, Tuesday, Thursday, and Friday of each week.

Troll: The troll fishery is open during periods the net fisheries are closed including:

- From May 28 through September 30, the troll fishery will be open from 12:01 a.m. to 11:59 p.m., Saturday of each week.
- From May 28 through June 17 the Deep Inlet THA west of 135°20.75' W. longitude will be open to troll gear, seven days a week, from 12:01 a.m. to 11:59 p.m.

Trollers are reminded that all fish retained within the boundaries of the Deep Inlet THA listed below must be reported as being harvested in statistical area 113-38.

The Deep Inlet THA is described as follows:

Deep Inlet THA: Deep Inlet, Aleutkina Bay, and contiguous waters south of a line from a point west of Pirates Cove at 56°59.35' N. latitude, 135°22.63' W. longitude to the westernmost tip of Long Island (56°59.85' N. lat., 135°21.83' W. long.) to the easternmost tip of Long Island (56°59.95' N. lat., 135°20.36' W. long.) to the westernmost tip of Emgeten Island (57°00.08' N. lat., 135°20.01' W. long.) to the westernmost tip of Error Island (57°00.53' N. lat., 135°19.50' W. long.) to the westernmost tip of Berry Island (57°00.32' N. lat., 135°18.68' W. long.) to the southernmost tip of Berry Island (57°00.27' N. lat., 135°18.51' W. long.) to the westernmost tip of the southernmost island in the Kutchuma Island group (57°00.14' N. lat., 135°18.27' W. long.) to the easternmost tip of the southernmost island in the Kutchuma Island group (57°00.07' N. lat., 135°17.93' W. long.) to the westernmost tip of an unnamed island at 57°00.30' N. latitude, 135°17.67' W. longitude to a point on the southern side of the unnamed island at 57°00.08' N. latitude, 135°16.78' W. longitude and then to a point on the Baranof Island Shore at 56°59.93' N. latitude, 135°16.53' W. longitude with the following restrictions:

Sandy Cove: all waters south of 56°59.05' N. latitude will be closed.

The Deep Inlet THA west of 135°20.75' W. longitude will be closed to purse seine and drift gillnet gear beginning with the first emergency order of the season through the third Saturday in June.


By emergency order issued under 5 AAC 33.376 (b) (4), drift gillnet fishermen will be required to fish with a minimum mesh size of 6 inches prior to June 17. The purpose of the minimum mesh restriction is to reduce the harvest of wild sockeye salmon returning to Silver Bay that are passing through the Deep Inlet THA.

By emergency order issued under 5 AAC 39.265, harvesters participating in net fisheries in the Deep Inlet THA fishery are required to retain and utilize all salmon harvested this season. This action is being taken in order to promote full utilization of salmon, to prevent waste of salmon, to determine harvest patterns of incidentally harvested coho and sockeye salmon, and to enable the department and NSRAA have full and accurate reporting of returns. This requires that all sockeye and coho salmon caught in the Deep Inlet THA fishery which are retained for personal use and not sold must be reported on fish tickets at the same time other salmon harvested during the opening are off-loaded and recorded on a fish ticket. Fishermen

are advised that if they have fish on board from other openings, in addition to the Deep Inlet THA fishery, they should keep them separate for reporting and sampling purposes.

Chinook Salmon Landing Restrictions for the Deep Inlet THA: Purse seine and gillnet fishermen must retain all Chinook salmon harvested in the Deep Inlet THA. Chinook salmon of any size harvested by both purse seine and drift gillnet fishermen may be sold. Troll fishermen may only retain and sell Chinook salmon greater than 28 inches.
