<u>Title:</u> Hatchery Technician <u>Location:</u> Medvejie Hatchery

Dates: ASAP through Nov 15, 2016

Duties: Medvejie Hatchery personnel will spawn and seed 90 million chum salmon eggs, rear over 3 million chinook salmon, and spawn 3,000,000 coho salmon eggs during the 2016 field season. The successful candidate will be involved in all facets of salmon fry and smolt production. Transportation between Sitka and Medvejie is provided. The candidate will provide transportation to and from Alaska (Sitka) at the beginning and end of the hiring period. Housing is offered free of charge in a communal apartment setting.

Qualifications: Education and/or experience in fisheries biology, fish culture, wildlife, or animal husbandry <u>is required</u>. Sound physical fitness is necessary due the physical component of hatchery work (i.e., ability to carry 50 pounds for distances over 100 yards. Employment may be contingent upon pre-employment alcohol and/or drug screening. Experience driving boats is preferred but not required.

Medvejie Hatchery is operated by Northern Southeast Regional Aquaculture Association (NSRAA), a private non-profit regional aquaculture association funded by the commercial fishing fleet in Southeast Alaska. NSRAA provides increased fishing opportunities for commercial, subsistence and sportfishing groups. We produce the largest enhanced Chinook salmon return in the state, as well as a large chum return and are one of the most economically important fishery enhancement programs in Southeast Alaska. Located in a remote setting in the heart of Alaska's Tongass National Forest, opportunities for outdoor recreation are unsurpassed.
