Chinook Cost recovery (CR) will be conducted as in past years. Chinook bids are being sought for Medvejie/Bear Cove near Sitka. All cost recovery operations will maintain the goal of providing high quality fish to the winning harvest rights bidder. The winning processors will have a licensing agreement for the CR fish and processor is required to supply the harvest boats. Tenders are optional but if needed the responsibility of the processor.

Processors will need to have a reliable harvest boat(s); this is essential to get the job done in a timely and efficient manner. Please provide a list of boat names and skippers that you plan to employ in the harvest of each species and/or site for which you submit a bid.
