NSRAA Request for Proposals 2024 Season Hidden Falls chum salmon EXTENDED DEADLINE

Dear Interested Salmon Buyers:

The Northern Southeast Regional Aquaculture Association (NSRAA) based in Sitka, Alaska is seeking proposals for the licensing right to harvest chum Salmon at the Hidden Falls hatchery for the 2024 season. This harvest is a defined portion of the summer run Hidden Falls stock chum salmon in excess of brood stock needs at the Hidden Falls facility. The Hidden Falls brood stock chum returns will be managed by common property fisheries and a small portion of cost recovery. We anticipate most, if not all of the cost recovery harvest, will occur in Kasnyku Bay. The projected brood stock needs and projected weekly return timing is attached.

This years' forecast chum salmon return to Hidden Falls is 1,553,000. NSRAA will be managing for brood stock needs (~240,000) with a controlled cost recovery effort in Kasnyku Bay.

Bid Criteria

This a single year bid for NSRAA Hidden Falls chum salmon. Harvest days, areas and volumes will be determined by NSRAA (licensor), in consultation with the winning processor, as necessary to assure adequate brood stock goals are met. Bid amount will be the number of pounds you are willing to harvest for **\$550,000.00**.

The winning processor will need to sign a NSRAA licensing agreement for the cost recovery harvest.

The cost recovery harvest plan for Hidden Falls is listed below:

Hidden Falls

For 2024, NSRAA is proposing to manage the Hidden Falls chum return in Kasnyku Bay for brood stock needs. There will be scheduled common property openings in the THA concurrently with cost recovery harvest. It is anticipated cost recovery harvest would occur the day before or after common property openings.

Once, the brood stock needs have been determined to be available by NSRAA, and the cost recovery goal has been reached, the remaining chum return will be managed by common property harvest to the greatest extent possible.
