



# Hidden Falls Hatchery Visitor Requirements For Private and Chartered Vessels



## Liability

Inherent risks include water hazards, electric bear deterrent fences, industrial operations and a large number of brown bears. NSRAA and the State of Alaska is not responsible for visitor safety.

## Permit Required for Commercial Operators

Hidden Falls Hatchery is located on Tongass National Forest land and State of Alaska tidelands. Commercially guided groups must be authorized by the Forest Service **and** registered with the State of Alaska.

Commercial operators intending to conduct “water ops” only in the vicinity of Hidden Falls Hatchery must be authorized by #2 above. Note at times that some tideland areas may not be accessible due to the presence of barrier nets and/or net pens.

## Group Limits

Visitors may be accepted between 9:00am and 4:00pm daily, with the last tour starting no later than 2:30 p.m. Site visits are limited to a maximum of 1.5 hours. Only one group with a maximum of 24 visitors may be on site at a time.

## Scheduling

Available tour slots can be viewed on the Google Calendar via the NSRAA website at <https://www.nsraa.org/>. Send requests to [HiddenFallsOA@gmail.com](mailto:HiddenFallsOA@gmail.com). Visitors may be turned away if another group is onsite or scheduled to visit.

## Site Access

Access to the site may be limited or denied due to work occurring, site conditions, or human-bear interaction dynamic.

The front side (east face) of the dock is for float planes only, except for the loading and offloading of passengers. Visitors are not permitted on the decks/steps of staff residences, as well as entering any buildings. There are no public restrooms available. The use of masks is recommended if social distancing cannot be maintained to reduce Covid-19 risks.

## Group Supervision

Groups must tour the site in a safe and respectful manner. Individuals must stay with their NSRAA guide, if provided, and not separate from the group.

## Visitor Safety

Hidden Falls Hatchery is a large scale salmon fishery enhancement program that is frequented by a large number of brown bears, and **NOT** a location for a bear viewing tour. Close interaction with the population of bears on site is strictly prohibited. Bear deterrence measures that may be in place during your visit include pyrotechnics and electric fences.

Please remain within the designated rope areas and DO NOT AT ANY POINT try to cross the weir as this area has extremely high bear activity.
